He has been Technology Adviser to successive Lord Chief Justices of England and Wales since 1998' and is President of the Society for Computers and Law.

He has written ten books, including *The End of Lawyers?* (2008), *The Future of the Professions* (2015, 2022, with D Susskind), and *Tomorrow's Lawyers* (2013, 2017, 2023). His work has been translated into 18 languages, and he has been invited to speak in over 60 countries. In the mid-1980s, he wrote his doctorate in AI and Law at Balliol College, Oxford.
